Our production processing lines are Hazard Analysis and Critical Control Point (HACCP) thanks to the hazard risk analysis and preventive measures we have taken to ensure food safety. Our factory buildings have passed the ISO 22000 Certification (food safety management system required for any organization in the food chain) by implementing various quality management points to ensure stable and excellent rice products processed under a high-standard production environment.

All certifications are issued by third party verification units. The quality assurance efforts reflect our commitment to product quality by offering open, transparent, and traceable products under the spirit of traceability. Our systematic management means that the consumers can enjoy our products without any worries.
